



MEMORANDUM OF UNDERSTANDING  
BETWEEN  
CHILANZAR DISTRICT, TASHKENT, REPUBLIC OF UZBEKISTAN  
AND  
SEODAEMUN DISTRICT, SEOUL METROPOLITAN CITY,  
REPUBLIC OF KOREA

This Memorandum of Understanding (hereinafter referred to as “MOU” ) is made and entered into upon the date of the final signature hereto, by and between Chilanzar District of Tashkent, and Seodaemun District of Seoul Metropolitan Government.

Whereas the Chilanzar District of Tashkent and Seodaemun District of Seoul Metropolitan Government desire to engage in cooperative development and exchange programs for the mutual benefit of the two organizations, the parties have agreed upon the following:

- I. By the signing of this MOU, the parties agree to develop and implement specific and timely actions that will promote and carry out exchanges and cooperation in numerous fields including, but not limited to, administrative, economic, cultural, educational, sports and tourism.
- II. By the signing of this MOU, the two parties agree to jointly develop leadership exchange programs for government officials in the public sector and leaders in the private sector to facilitate mutual exchanges and cooperation between the two governments in the areas identified in section I. above.
- III. The parties will support each other’s common goal of providing infrastructure that is supportive of sustainable growth, is environmentally sensitive, and is fiscally sound; and enhancing and sustaining the quality of life in the community.

IV. The two parties agree to develop specific activities that will result in cooperation in sharing information, knowledge and ideas, as well as resources, which will help in the promotion of economic and entrepreneurial activities within, as well as between, the two governments and their respective organizations.

V. All activities developed hereunder this MOU will be in accordance with all applicable rules and regulations of the parties, and all applicable federal, state, and local laws, rules and regulations. This MOU will be in effect for a period of three (3) years from the date of execution and may be renewed for additional three (3) years by the parties. Either party, by written notice to the other party (90) days before the desired date of termination, may terminate the agreement provided that such termination will not affect the completion of any activity underway at the time. All modifications to this MOU must be in writing and signed by both parties.

This MOU is made in Korean and English signed at the city hall of Seodaemun District of Seoul Metropolitan Government on 21 November 2017.
