Dear Member,

Please find hereunder the detail of your 2019 fee calculation.

As an operator member, your fee is based on your 2017 consolidated audited operating costs.

August 2018 OECD index (average worldwide inflation rate) of 3,0% is applied.

In order to better understand the table and the result of the calculation, here is the detail formula:

Operating costs x Rate = X

X + Fixed = Y

Y + OECD index = Basic fee

EU, EU candidates, Norway, Monaco, Liechtenstein, Switzerland and Iceland members only:

Basic fee + 7,5% EU contribution = Total fee

TERMS & CONDITIONS

Invoice is payable within 60 days of invoice date. In case of non-payment at the due date, the amount of the invoice may be automatically raised by 5% and the following action will be taken:

- After 60 days term (2 months), a first reminder will be issued.
- After 90 days term (3 months), a second reminder will be issued. Should payment still be failing 2 weeks after the reminder, the company's access codes to the member portal will be temporarily blocked;
- After 120 days (4 months) from invoice date, a third reminder will be issued. If payment is still failing 2 weeks after the second reminder, all services will be temporarily suspended, the member company will therefore not be able to claim member rates for events, trainings, publications... or to participate to working bodies;
- After 150 days (5 months) from invoice date, a fourth and final reminder will issued. Should payment still be failing 2 weeks after the reminder; the member company will be listed for cancellation and the file will be transmitted to the debt collector agency.

Please note that temporary suspension of services does not release from the payment obligation.

In case of resignation, written communication addressed to the Secretary General must be sent within 30 days of the issue date of the membership invoice, as per our By-Laws recently approved at our Extraordinary General Assembly in Brussels last November 2018.

Invoices are payable by bank transfer or credit card (Amex, Visa, Mastercard). Bank checks will unfortunately be returned to their emitter.

EU VAT 2010/45 regulation applies. The invoice is drawn according to the information provided by your organization. Should the VAT N° or your VAT liability status be incorrect, we will be forced to re-invoice Belgian VAT of 21%.
