

#### SERVICE AGREEMENT

AN AGREEMENT made the 14 day of September two thousand and twelve BETWEEN

**E.M.I. Ente Moda Italia S.r.I.**, a company existing and organized under the laws of Italy, having its registered office at via Faenza no 109/111, I-50123 Firenze, Italy, represented by its Managing Director Dr Alberto Scaccioni, (hereinafter referred to as "EMI"),

#### and

People of Tastes (POT), a company existing and organized under the laws of Korea, having its legal seat at 105, b 101, 335-4 SeoGyoDong MaPo-Gu, Seoul, Korea, represented by its General Manager Ms Misun Song, (hereinafter referred to as "Consultant").

#### **WHEREAS**

EMI organizes twice a year an Italian Fashion Exhibition (the "Exhibition"), whose venue is selected year by year;

EMI provides to invite Italian fashion producers to exhibit their products in such Exhibition;

EMI needs a Korean support to organize the logistic aspects of the Exhibition, the relations with media, the advertising for Korean buyers and other consulting support for the Exhibition;

POT has the experience and the organization to provide the above mentioned services, and is willing to do so;

In consideration of the covenants, terms and conditions set forth herein, EMI and Consultant agree as follows:

#### 1. Services.

- 1.1 Consultant shall organize for EMI all the logistic and commercial aspects of a fashion event to be held in Seoul twice a year. Venues and dates shall be agreed between the parties by three months before the beginning of the Exhibition
- 1.1.1 Particularly, the Consultant shall:

- a) Promote the event with Korean Menswear, Womenswear and Kidswear fashion buyers (hereinafter referred to as "buyers") so that as many of them as possible attend the event;
- b) Get in touch with Korean buyers in the perspective of the following event:
- c) Send invitation cards (supplied by EMI) to selected buyers;
- d) Keep relationship with local media to publish advertisings (decided and paid up by EMI);
- e) Organize interviews;
- f) Get in touch with local suppliers to set up the area;
- g) Get in touch with venues' managers to grant the due course of the event:
- h) Have the event catalogue and necessary panels with the names of the Exhibitors translated into Korean and printed;
- Organize, if requested, a visit to Seoul most important multibrand boutiques and department stores (shuttle bus paid by EMI);
- j) Supply EMI with a detailed list of names and addresses of all the event visitors, in Excel format, in English.

The Services shall be performed by Consultant.

1.2 During the term of this Agreement, Consultant shall ensure that each of the Consultant team members diligently and conscientiously performs and discharges, to the best of his/her ability, the tasks and responsibilities described in para 1.1.1. All data and information obtained by Consultant pursuant to this Agreement shall be made available upon request, within a to the duly-authorized representatives of EMI. reasonably short time, Consultant shall contact EMI through Mr Alberto Scaccioni or Mrs Giovanna addresses: 055214835 e-mail +39 Phone: Pela. Del alberto.scaccioni@emimoda.it, giovanna@emimoda.it, for approval of all services here above.

#### 2. Term.

2.1 This Agreement enters into when the latter party has signed it.

This Agreement shall remain in force for the next three years and for all the related editions of the Exhibition and shall be automatically renewed for the following three years unless early terminated by either party by 6 (six) months advance notice.

2.2 Upon termination of this Agreement for any reason, EMI shall pay Consultant all unpaid amounts earned prior to such termination, but shall not be responsible for payment of any amounts not earned prior to such termination.

If Consultant breaches any material term of this Agreement, EMI may, in

addition to any other remedy, immediately terminate Consultant's services by advising Consultant of the same by letter, fax, telephone call, in person, or other reasonable means.

In the event this agreement is early terminated by EMI for any reason, the Consultant shall not be entitled to receive any indemnity or indemnification or any kind of compensation.

The provisions of Articles 4, 5, 7, 8, 13 and 14 shall survive termination or expiration of this Agreement.

#### 3. Reward and Payment.

- 3.1 The fees, for the Consultant Services, are agreed on the amount of Euro 16.000,00 (sixteen thousand euro) for each edition.
- **3.2** EMI will pay the Consultant fifty percent (50%) of the above fees (Euro 8.000,00 (eight thousand euro) within thirty (30) days after the latter party has signed this Agreement.

EMI will pay the Consultant the balance within thirty (30) days on satisfactory completion of the services and upon receipt of the written final report.

#### 4. Confidentiality.

- **4.1** During the course of this Agreement, EMI may provide Consultant with confidential or proprietary information which, (a) if in written form, is marked "Confidential," (b) if in oral form, is identified as confidential at the time of oral disclosure or is summarized in a writing marked "Confidential" delivered to Consultant within fifteen (15) days after the oral disclosure, or (c) if further disclosed, could reasonably be expected to result in competitive harm to EMI (collectively, the "Confidential Information"). Consultant shall maintain all Confidential Information in confidence and shall use it solely to perform the Services.
- **4.2** The foregoing obligations of confidentiality and non-use shall not apply to information that Consultant is required to disclose by Law, provided that Consultant gives EMI as much advance notice of the intended disclosure as can practicably be given, or to information that: (a) is shown by contemporaneous documentation of Consultant to have been in its possession prior to receipt from EMI, (b) is or becomes, through no fault of Consultant, publicly known or (e) is furnished to Consultant by a third party without breach of a duty to EMI.
- **4.3** Upon termination or expiration of this Agreement, or upon EMI's request, Consultant shall return to EMI or destroy (as EMI directs) any notes, copies, summaries or extracts of the Confidential Information.

#### 5. Legal Notices.

5.1 All notices required or permitted to be given under this Agreement shall be

#### 6. Other Engagements. Conflict of Interest.

**6.1** Consultant may consult with such persons, firms, or corporations as Consultant deems advisable, upon the condition they are not or do not intend to work for EMI competitors.

Consultant represents and agrees, however, that Consultant is not and shall not become a party to any agreement that conflicts with EMI interests and/or with Consultant's duties hereunder.

#### 7. Indemnification.

7.1 Consultant shall indemnify and hold EMI and its officers, employees, agents and representatives harmless from and against any and all losses, damages or claims of liability (including reasonable attorneys' fees) arising out of Consultant' or its employees' performance of the Services or other act or omission to act under this Agreement.

#### 8. Independent Contractors.

**8.1** Consultant and its respective employees, consultants and representatives shall not be considered employees, partners, or agents of EMI. Neither Consultant nor its staff shall participate in any EMI employee benefit plans or receive any compensation beyond that provided for herein. Neither Consultant nor its staff shall make any representations or commitments on EMI's behalf or use EMI's name or trademarks in any public disclosure, without EMI's prior written consent.

#### 9. Benefit and Assignment.

**9.1** This Agreement shall be binding upon and inure to the benefit of the heirs, legal representatives, successors and assigns of the parties hereto, provided, however, that neither Consultant nor EMI may assign or transfer this Agreement without the written consent of the other party, except that EMI may assign its interest in this Agreement without the consent of Consultant to any of its affiliates or to a purchaser or other transferee of the portion of EMI's business to which the services described herein relate.

#### 10. Modification and Waiver

10.1 This Agreement may not be modified or amended in any way except by mutual written agreement of the parties. No waiver shall be binding unless executed in writing by the party making the waiver, and the failure of either party to enforce any provision hereof, or any right hereunder, shall not be construed as a waiver of such provision or right. No waiver of any of the provisions of this Agreement shall be deemed, or shall constitute, a waiver of any other provision, whether or not similar, nor shall any waiver constitute a continuing waiver.

#### 11. Severability.

11.1 If any provision of this Agreement becomes or is deemed to be invalid, illegal or unenforceable, this Agreement and the remaining provisions thereof shall continue in full force and effect.

#### 12. Entire Agreement.

**12.1** This Agreement is the entire agreement between the parties with respect to the subject matter hereof and supersedes any prior negotiations and agreements.

#### 13. Governing Law.

**13.1** This Agreement shall be governed and construed in accordance with the substantive laws of Italy, without regard to the conflict of Laws principles thereof.

#### 14. Competent Court.

**14.1** Unless the parties can amicably resolve any dispute, difference, controversy, claim or question which may arise at any time hereafter between the parties with regard to the interpretation, fulfillment and termination of this Agreement, the Court of Firenze, Italy, shall be the sole competent Court.






